"De-escalation Overview for WI Police Executives"



A 34-year law enforcement veteran, Chris Butler recently retired as an Inspector for the Calgary Police Service. For several years Chris was in charge of the delivery of all officer safety, subject control tactics, emergency vehicle operations, Incident Command and Strategic Communication training for the Calgary Police Service in Calgary, Alberta Canada; a major Canadian police agency of over 2,000 sworn officers.

During Chris's law enforcement career, he has been member of the Public Safety Unit for over 12 years and during this time was involved in conducting risk assessments and planning operational tactics for events such as the World Petroleum Congress and the G8 Summit. Chris is certified as an instructor or instructor trainer in numerous firearms, combatives, less lethal/chemical agents and emergency vehicle operation techniques. In addition, Chris has training in Incident Command, special event risk management and is certified as a close protection specialist (ESI – honors).

Chris has been qualified at Provincial and Federal court as an expert in firearms safety, police firearms training, law enforcement use of force training and evaluation and is used as an expert witness on law enforcement use of force in criminal and civil court cases across Canada. Chris is certified as an Advanced Force Science Analyst and regularly gives presentations to law enforcement audiences across North America as part of the Force Science Institute instructional cadre.

He previously served as Captain of the Investigations Division of the Green Bay Police Department and was with that Department in varying capacities, including Patrol Officer, Investigator, and Captain during his 26 years there. He previously worked the Clintonville and Combined Locks Police Departments and the Marquette County Sheriff's Department. He was a Unified Tactical Instructor for 10 years at several technical colleges.

He has been the coordinator of the State of Wisconsin Law Enforcement Death Response Team since January of 2015 and has unfortunately had to assist agencies across the state with (27) Line of Duty Deaths or Suicides.

Chief Thomas earned a BA from Concordia University in Criminal Justice. Additionally, he is a graduate of the FBI National Academy and the Executive Development Institute. He has been awarded Green Bay Police Department's Officer of the Year, (3) Distinguished Service Medals with Valor and a Governor's commendation for his volunteer work with the Special Olympics.

In use of physical force in all police calls.



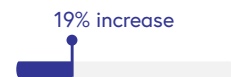
In use of weapon force in all police calls.
